## **ELIGIBILITY**

This event is for Club or Competitive Members who are registered in the SNZ database and their membership

indicator are financial as at the date of the meet.

Qualification Criteria

Age as at 8th July 2022. The qualifying period 1 January 2019 to 5 July 2022.

The qualifying times are 25m Short Course times. LC converted entries accepted if no SC time available on

the database. Individual entry times will be generated by the SNZ Database.

## **INDIVIDUAL ENTRIES**

Entry seeding time to be used. All entry times must be achieved within the qualifying period to enter. The following exception applies for the following categories:

- (a) Female/Male 50m Backstroke, Butterfly, Freestyle & Breaststroke
- (b) Female/Male 200m Butterfly

There is no qualifying time required for these (a) & (b), as NT accepted, however a time is still required for entry. Please provide the trial time for NT events.

## ATHLETES WITH A DISABILITY/PARALYMPICS

Athletes with a disability are eligible to participate in this meet and will be seeded amongst able-bodied athletes on the basis of entry times. It is the responsibility of the athlete with a disability (or their Team Manager) to inform the Referee before they swim of their disability. The Referee will use their best efforts

to judge the swim under the athlete's circumstances.

Qualifying Times does not apply to Athletes with a Disability.

Para swimmer, please enter online for any 50m event(s), and thereafter contact Evolution Club Recorder to enter on your behalf for any other distance events you wish to race.

Payment for manual entries will be

made online via SNZ database.

## RELAY

There are no relay events in this meet.

## **MEET PROGRAM**

Meet Management may limit entries to ensure reasonable session lengths.

Electronic timing will be used at this meet.





## **ENTRY PROCESS**

All entries must be registered via the SNZ National Database. Individuals will be able to access and complete their entries online via Fastlane.

Online entries are now open. All swimmers who entered prior to the 1st July, you must renew your annual SNZ subscription on the 1st July 2022. Every club recorder or club admin, or your region admin must check that their swimmers are financial. Failure to renew subscription will result in entries being removed.

## **CLOSING DATE IS 5TH JULY AT 22:00 HOURS.**

Late entries accepted for the next 24 hours (exp 6th July @ 22:00) from the above closing date/time with a \$50 late entry meet fee added to your online late entries booking.

No further late entries can be accepted after 6th July at 22:00 hours onwards.

## **ENTRY FEES**

Entry fees \$12.00 NZD per individual event, registered via SNZ Database.

Entry fees must be paid prior to the start of the meet. If they have not been paid it will result in the withdrawal of swimmers.

#### **PSYCH SHEETS**

Preliminary & Final Psych Sheets will be posted on the Evolution Aquatics Tauranga website where registered swimmers will receive a notification email from our Club Recorder.

## **AGE GROUP TIMED FINALS**

Timed finals will apply to 11 & Under Events, seeded to swum as mixed gender boys & girls.

Timed finals will apply to 12 & Over - 400m Free, 400m IM, 200 Fly, 800 Free, 1500 Free. 800/1500 Free - Top 20 Male & Top 20 Female - a swimmer can only race either, not both.

## **AGE GROUP HEATS/FINALS**

12&Over - Heats seeded as mixed age, separate gender men/women. Fastest 10 of each gender will swim Finals in Age Group 12/13, 14/15, 16 & Over.

## **AGE GROUP POINTS**

Top 10 placing for Finals or Timed Finals events will score points accordingly. Points are accumulative, they are calculated to total up upon the completion of Session 5. Heats events do not score any placing points.

## **CASH PRIZES \$\$\$**

Awarded for all 1st, 2nd and 3rd FINALS or TIMED FINAL event(s) place getters for Age Group 11 & Under, 12/13, 14/15, 16 & Over.

Cash prizes will be distributed at the table, to be collected and signed by Team Manager on behalf of the swimmers.





## **SKINS QUALIFYING**

Must enter a minimum of any 4 individual events (either heats or timed finals) to participate in SKINS.

However, top FINA Points will be taken from HEATS Swim only for one of their best event FINA score. Top 10 Female and Top 10 Male will race SKINS in each specified category. Swimmers announced at start of Session 5. Swimmers 11 & Under are not eligible for the SKINS events.

#### **SKINS RACING**

5 heats on 1:30. Slowest 2 swimmers eliminated. Electronic timing is final. Random order stroke will drawn for each heat.

#### WITHDRAWALS FOR HEATS/TIMED FINALS

NO REFUNDS for any withdrawals will be given once entries have closed. However an exception is made for an athlete who suffers an illness or injury. A copy of medical certificate from a medical practitioner is required for the purpose of refund. This needs to be reported before the Meet Programs are printed. Once the Meet Programs are drawn or printed, there are no refunds (inclusive medical) under any circumstances.

## WITHDRAWALS & PENALTY FEES FOR FINALS

Please note that withdrawals for Session 1, 2, & 4 FINALS (12 & over) must be submitted to the AOD control room within 30 minutes of finalist's results being posted. A scratching fee of \$5.00 will apply accordingly to each individual race event. Please attached or stapled \$5.00 to the withdrawal form.

Failure to submit withdrawal form after 30 minutes of the results being posted will incur a penalty fee of \$50.00 per swimmer per event.

## NO SHOW FOR FINALS EVENTS (PENALTY FEE)

A penalty of \$50 per Finals per event, will be charged for non-withdrawal or No Show at Marshalling.

## **PROTESTS**

Protest fee = \$100. Payable upon submission of correctly completed protest form.

## **ENTRANCE**

Pool entry to the event is free for swimmers, team managers, officials, and coaches. Baywave Pool charge a spectator fee for each session entry.
